## Information on toxicological effects

<b>Inhaled</b>	The material is not thought to produce adverse health effects or irritation of the respiratory tract (as classified by EC Directives using animal models). Nevertheless, good hygiene practice requires that exposure be kept to a minimum and that suitable control measures be used in an occupational setting. Inhalation hazard is increased at higher temperatures.
<b>Ingestion</b>	High molecular weight material; on single acute exposure would be expected to pass through gastrointestinal tract with little change / absorption. Occasionally accumulation of the solid material within the alimentary tract may result in formation of a bezoar (concretion), producing discomfort. Environmental Fate: Siloxanes are used in cosmetics, wax, polishes, and to a minor extent in several other applications.

Atmospheric Fate: In the presence of nitrate ions, short chain siloxanes are broken down by sunlight to the level of silicate within days. The main source atmospheric siloxane release to the air is via evaporation.

Aquatic Fate: It is well accepted that polydimethylsiloxane fluids become permanent residents of sediment but should not have adverse environmental effects.
